

Chair's Report

Another year – and another struggle to continue providing the valuable and essential services that support our community and our legal system.

I am very tempted to write this year just a single sentence report – “see last year’s message, nothing has changed”. It is so disappointing to have to acknowledge yet again that our staff and volunteers have worked tirelessly to bring justice and recognition to those who would otherwise suffer significant hardship and injustice. For another year, our pleas (and my anger) have been ignored. Right now we are in the process of seeing a new Government installed - one which campaigned on the need for change - so maybe there is some grounds for hope, but hope is a luxury we have learned to live without.

Again this year I want to record the gratitude of the Board to our staff and all the volunteers who provide the legal service of which we are justifiably proud. Elsewhere in this report are the statistics which show what form that service has taken, and to whom it has been delivered. Suffice to say here that the legal services, education and ‘last resort’ support provided by Community Law Waikato, in communities throughout the area, is of very high quality in both professional and personal terms. People come to us often, after seeking help from a long list of other options, in despair and frustration. We believe they leave us with a feeling that they have been listened to, given support and a way through whatever difficulty they are experiencing, but most of all with hope and trust in their fellow humans. This is our reward and the feedback we receive, some of which is printed in this report, bears testimony to that. We treasure this feedback because there is little other recognition of our efforts. As a Board we struggle to live with the low salaries we have no choice but to pay to hardworking, dedicated staff. The major proportion of our budget goes to salaries, with just enough ‘left’ to maintain the operation. Even so, we are well aware of how inadequate this is.

This year has seen two new Trustees join the Board. David Allen replaces the late Peter Gorringe as our practising lawyer Trustee. We are enjoying David’s lively and intelligent input and his hands-on experience with the local and national legal scene. Patience Te Ao from Tainui has already made a great contribution and is invaluable in maintaining close and effective links with our tangata whenua. We welcome both these Trustees and are very happy to see how well they fit into the group, making excellent contributions to the collaborative and friendly processes of our meetings.

This year we did get a boost to our budget via the national Law Centre body (CLCA), who negotiated an additional amount to share among all Law Centres. This money comes from three more of the major banks who have agreed to donate a proportion of the interest accrued on trust accounts. This is making a huge difference for us – well, “huge” in that it is the first improvement we have seen in a long time, and goes some way toward meeting the deficit built up over the 10 years that the Government grant has remained unadjusted. We will be using this extra amount with great care to ensure it enhances our ability to provide appropriate, quality service to those we work to support.

To conclude; again I reiterate wholehearted gratitude to all who work with and for the Centre, and especially for their unfailing enthusiasm and positivity. To the staff and volunteers who provide the legal services and education that underpin our existence and support the legal system of New Zealand and the Trustees who take such care to ensure our meagre budget is used as wisely and effectively as possible. The celebration I dreamed of in my report last year most certainly has not yet been warranted. Dare I hope again?

Managing Solicitor's Report

I am pleased to report the survival of yet another challenging year. As I mentioned previously, the motivating force for our operation lies in the facilitation of access to justice and ultimately the contribution to positive social change. The results of the efforts and dedication of the Centre's governance and staff, volunteers, and other agencies are evident throughout this report. The team and all those involved has done a tremendous job.

It is with sincere gratitude that I thank the outstanding efforts by everyone. Again, I make a special mention of our Trustees and staff who grapple on a daily basis with the overwhelming and genuine pleas for help by individuals in the community. Our team has worked through various challenges, some taking more of a toll than others, and I am incredibly proud of the way in which we have stuck together and supported each other.

The search for a sustainable funding solution remains on the forefront both at a local and national level. At a local level we continue to receive some community grants however with more NGOs desperate for funding it is becoming more difficult to obtain. On a national level, the funding injection from the banks have provided a significant degree of financial relief. We are able to use a portion of this funding to sustain our current operational structure (covering the financial loss) and put the rest towards the cost of expansion. We are still in the process of exploring revenue streams to support the core service.

A number of staff changes presented the usual challenges of time, cost, and training all whilst at the same time maintaining service levels. With an additional lawyer now on board and the return of our Assistant Managing Solicitor from maternity leave, we are again armed with a full force going forward.

The Ministry of Justice commenced a review of community legal services early this year and the process will be ongoing for the next 18 months to two years. It entails past client and general public surveys, profile building for all community law centres, a funding distribution review, and other aspects of modernisations of community legal services. Despite adding an additional layer of work, the ultimate aim is to create a stronger business case for sustainable funding within the justice budget. In the short term this should also help centres evaluate their operations and plan for the future.

Overall, despite the past year being full of challenges, it has been a rewarding experience. I thoroughly enjoyed working alongside an amazing and inspirational team.

My role as a Community Development Co-ordinator involves liaising and networking within the community. This is an important aspect for our Centre to promote awareness in the larger community, promote Community Law Waikato's services and regularly attend community network meetings and public meetings.

LEGAL EDUCATION

This year we delivered a total of **124 education sessions** - 100 in-house or customised seminars and 24 Law and You Seminars at High Schools in the Hamilton and Waikato area. Thank you to the **1918 attendees** who contributed towards its success.

CUSTOMISING SEMINARS

Community Law solicitors deliver 1-3 customised seminars per month to organisations such as: **Citizens Advice Bureau's, Local Community Houses, Wintec Hamilton, Grey Power and the Settlement Centre Waikato** to name a few.


We have worked with **Turangawaewae Marae** this year delivering education sessions on Wills & Power of Attorney to the **Kaumatuā Continuing Education Group**, we also ran the same sessions with **Maniapoto Marae Pac Trust**.

We also delivered:

- Three seminars per month during July- December 2016 to offenders completing community work with the **Department of Corrections**
- Bi-monthly seminars to assist new refugees settling in Hamilton at the **Red Cross**
- A series of reunification workshops for new migrants/refugees at the **Settlement Centre Waikato**
- A series of seminars on Wills & POA, Tenancy, Employment and Consumer Law in association with the **Ngaruawahia Community House**
- A **10 week evening course** at Community Law Waikato for participants who could only attend night time classes

We also developed and delivered in Hamilton an intensive two day Employment Workshop in association with **Community Waikato**.

Community Law Waikato (CLW) provided free legal services in communities throughout the Waikato. Our clinics are crucial in ensuring individuals and communities have access to justice.


We have 11 Outreach clinics in the Waikato serviced weekly/fortnightly by our solicitors.

Ngaruawahia Clinic

In May 2016 we were approached by the Ngaruawahia Community House to provide free legal services in the region. The outreach clinic is serviced by our solicitors and held at Ngaruawahia Community House fortnightly.

In the July 2016 to June 2017 funding year we assisted **76** members of the Ngaruawahia and Huntly communities with their legal needs. The areas of law we provided assistance with were: family law, care of children, traffic, debt, tenancy, employment and more.

CLW has been generously supported by SkyCity Hamilton Community Trust with a grant of \$15,000 to provide this essential service. Through this funding we were also able to provide legal education to **110** year 12 and 13 students at Ngaruawahia High School and to **44** members of the Ngaruawahia community on Consumer Law, Employment and Tenancy law and Wills and Powers of Attorney. Immigration Clinic

CLW was approached in March 2016 by the Settlement Centre Waikato (SCW) (formerly the Migrant Resource Centre Hamilton) to provide free legal services at their centre. SCW is often the first place a migrant or refugee will go to ask for help on a range of issues and there is a huge, growing need for legal services amongst migrants. Immigration issues are often very complex and require specialist advice and assistance, particularly for refugees as they don't have the financial resources to pay for the services of a lawyer or immigration consultation. 'Decypher' provides free translation services for each person who seeks legal services through CLW at the SCW.

In the July 2016 to June 2017 funding year we assisted **115** individuals with their immigration legal needs at SCW .

This service was generously supported by DV Bryant Trust who granted \$2,000 to assist with providing legal services to migrants in Hamilton. We continue to seek other funding streams to assist us with providing these services and enable us to offer migrants translated legal education on a range of Immigration Law topics, particularly Reunification.





INDEPENDENT AUDITOR'S REPORT

To the Trustees of Community Law Waikato Trust

Report on the Performance Report

Opinion

We have audited the performance report of the Community Law Waikato Trust, which comprises the entity information, the statement of service performance, the statement of financial performance and statement of cash flows for the year ended 31 December 2016, the statement of financial position as at 31 December 2016, and the statement of accounting policies and other explanatory information.

Opinion on the entity information, statement of service performance and financial information other than the statement of financial position

In our opinion, the performance report presents fairly, in all material respects, the entity information, statement of service performance and financial position of Community Law Waikato Trust as at 31 December 2016, and cash flows for the year then ended in accordance with Public Benefit Entity Simple Format Reporting – Accrual (Not-For-Profit) issued by the New Zealand Accounting Standards Board.

Qualified Opinion on the statement of financial performance

In our opinion, except for the effects of the matter described in the Basis for Qualified Opinion section of our report:

- a) the reported expenses and revenue items; LSA Operating Grant, Donated Assets, Professional Fees, Interest Received, Professional Fees, Rent Received, are presented fairly, in all material respects.
- b) the performance report presents fairly, in all material respects, the financial performance of Community Law Waikato Trust for the year ended 31 December 2016 in accordance with Public Benefit Entity Simple Format Reporting – Accrual (Not-For-Profit).

Basis for Qualified Opinion

As reported in the statement of financial performance on page 15, the entity has received grant revenue and cash revenue as reported under the donations and sundry headings. These revenue items cannot be fully verified as being complete due to the limited control over these revenue items before they are recorded and therefore remain at risk of being materially misstated. For these reasons we cannot conclude that the statement of financial performance for Community Law Waikato Trust as a whole is presented fairly in all material respects.

We conducted our audit of the statement of financial performance, statement of financial position, statement of cash flows, statement of accounting policies and notes to the performance report in accordance with International Standards on Auditing (New Zealand) (ISAs (NZ)), and the audit of the entity information and statement of service performance in accordance with the International Standard on Assurance Engagements (New Zealand) ISAE (NZ) 3000 (Revised). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Performance Report* section of our report. We are independent of Community Law Waikato Trust in accordance with Professional and Ethical Standard 1 (Revised) *Code of Ethics for Assurance Practitioners* issued by the New Zealand Auditing and Assurance Standards Board, and we have

fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

We have assisted in compilation of the Performance Report. Other than this, in our capacity as auditor we have no relationship with, or interests in, the Community Law Waikato Trust.

Other Information

The Trustees are responsible for the other information. The other information comprises the information included in the entity's annual report, but does not include the performance report and auditor's report thereon.

Our opinion on the financial statements does not cover the other information and we do not express any form of audit opinion or assurance conclusion thereon.

In connection with our audit of the performance report, our responsibility is to read the other information, and in doing so, consider whether the other information is materially inconsistent with the financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated. Of, based on the work we have performed, if we conclude that there is a material misstatement of this other information, we are required to report the fact. We have nothing to report in this regard.

Responsibilities of the Trustees for the Performance Report

The Trustees are responsible for:

- (a) Identifying outcomes and outputs, and quantifying the outputs to the extent practicable, that are relevant, reliable, comparable and understandable, to report in the statement of service performance;
- (b) the preparation and fair presentation of the performance report on behalf of the entity which comprises:

- (c) such internal control as the Trustees determine is necessary to enable the preparation of the performance report that is free from material misstatement, whether due to fraud or error.

In preparing the performance report, the Trustees are responsible on behalf of Community Law Waikato Trust for assessing the Trust's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the Trustees either intend to liquidate Community Law Waikato Trust or to cease operations, or have no realistic alternative but to do so.

Auditor's Responsibilities for the Audit of the Performance Report

Our objectives are to obtain reasonable assurance about whether the performance report is free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of this performance report.

As part of an audit in accordance with ISAs (NZ) and ISAE (NZ) 3000 (Revised), we exercise professional judgement and maintain professional scepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the performance report, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.
- Conclude on the appropriateness of the use of the going concern basis of accounting by the trustees and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Trust's ability to continue as a going concern. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Trust to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the performance report, including the disclosures, and whether the performance report represents the underlying transactions and events in a manner that achieves fair presentation.
- Perform procedures to obtain evidence about and evaluate whether the reported outcomes and outputs, and quantification of the outputs to the extent practicable, are relevant, reliable, comparable and understandable.





BANK DONATIONS

Community Law Centres throughout New Zealand have received a significant funding boost through the generosity of BNZ, TSB, ASB, ANZ and Westpac banks. These banks have reduced the amount of trust account interest they hold and have instead passed it on to Community Law Centres for the next three years. This has increased Community Law Waikato's capacity to provide legal services to the vulnerable in our community.

The demand for free legal services continues to increase whilst at the same time the level of funding from the Ministry of Justice has remained the same for the past ten (10) years.

The Ministry of Justice provides 95% of our funding.

We were generously supported by The Lotteries Commission and SkyCity Hamilton Community Trust who provided grants of \$30,000 and \$15,000 respectively.

CLW actively continue to search for other funding streams to support our services.

Our staff are our greatest assets. They are the people that breathe the life into our projects and they are often the face of our service. Our staff can determine the success or failure of our organisations. As Managers and Coordinators of community organisations we have a dual responsibility to protect our staff and to protect our organisation. So what do we do when the relationship between manager and staff member become strained, or even worse, completely breaks down?

While it is essential for managers to support their staff and protect their wellbeing in the workplace, this must be balanced with the role of protecting the organisation. Each group has a vision and a mission, and most of us rely on donations and grants to deliver on this mission. If an employee is not performing or their behaviour brings disrepute upon the organisation, we put at risk not only our reputation, but the financial contributions that we have been charged with using for community impact.

Balancing the needs of our staff and the needs of our organisation is the responsibility of the Manager and the Board. But navigating employment law can be a daunting prospect for even the most seasoned manager. It is crucial to understand what constitutes performance

management and what behaviour oversteps the parameters of performance management. This can make staff feel under-appreciated or potentially bullied and is counter-productive to achieving a positive outcome for staff and for the organisation.

Employment law is based on process. It is essential to get those processes right, in order to protect your staff and protect your organisation. But where can you go to get the information you need to get this right? There are some great resources online at Employment New Zealand (<https://employment.govt.nz/>) where you can access information on minimum rights, leave entitlements and starting and ending the employment relationship.

Added to this, Community Waikato and Community Law have been discussing how we can best inform our sector about a wide range of employment law topics. We are running workshops for those who want to learn more about employment law. For the details, check out our training calendar at the end of this Kumara Vine. Protecting our organisations in an essential role of the Manager and the Board but this must be balanced with safeguarding the wellbeing of our staff. When we get this right, everybody wins.







(Please note: this is not an exhaustive list of what we do).

ACC	E.g. Entitlements, lump sum payments, sensitive claims, impairment assessments, cover disputes, mediations and review hearings.
Consumer	E.g. Faulty goods (including motor vehicle disputes), contract disputes, repossessions, Fair Trading Act breaches/complaints and Disputes Tribunal claims.
Minor Criminal & Traffic	E.g. Drunk Driving, Careless Driving, Dangerous Driving, Driving Whilst Disqualified, breaches of limited licences (“work licences”), Refusal to Give Blood, Boy racer charges, Possession of Drugs, Disorderly Behaviour and Theft, We deal with sentencing, defended hearing and special applications, for example: hardship applications for vehicles etc.
Debt issues	E.g. Creditor claims, credit contracts, interest rates, insolvency options like ‘No Asset Procedures’ (NAP) and Bankruptcy, and debt disputes .
Disputes Tribunal	E.g. Assistance with application and response to applications if required.

WINZ	E.g. Entitlements, paternity declarations, investigations, disputes including Review Hearings and Social Security Appeals. Also including situations where WINZ reduces benefit for failing to name father of a child.
